In Bengal, Muslim administrators additionally postponed bills to change Muslim relationships. The Bengal Muhammadan Marriages and Divorces Registration (Amendment) Bill, 1934 by K. Nazimuddin was an endeavor to correct the Bengal Muhammadan Marriages and Divorces Registration Act, 1876. It was proposed to enable a Muhammadan Marriage Registrar to enroll the class of separation known as Talaq-I-bilyad, in which the spouse affected the separation as per the authority presented upon her by her better half as a state of marriage. Most of the women on the electoral roll, or a large proportion of them, might not be welcome in this assembly, and I think it is quite likely that people who wish to bring this House into disrepute might arrange somehow or other, if the sex disqualification were removed, for some of these women to be returned to this Council...is quite likely that the women who would be ornaments to this Council would not care to face the rough and tumble of an election. (Cf., Kaur, 1968, p.113)

This assertion refuted absolutely when in 1933 Jyotirmoyee Ganguly and Kumudini Basu were chosen the primary ladies Municipal Councilors of the Calcutta Corporation and Nellie Sen Gupta, spouse of J. M. Sen Gupta, chose Alderman for the Corporation of Calcutta. The Modern Review lamented that Bengal failed behind most territories. Later in the 1937 decisions, the vast majority of the ladies individuals were chosen as opposed to being named.

The issue of ladies schooling survived from incredible concern, even a century after its presentation in Bengal. Mira Datta Gupta, an educationist, talked at extraordinary length. Hemaprova Majumdar subsequent to being chosen in the Bengal Legislative Assembly in 1937 got some information about the current number of female detenus and political detainees in Bengal and the names of various prisons where they were interned. Sir Nazimuddin answered that there were six female detainees sentenced for homicide or other psychological oppressor offenses and one detenu in the correctional facilities of Bengal. They were in Presidency, Midnapore, Dacca and Dinajpur correctional facilities. The detenu had three female convicts as specialists and she had expressed recorded as a hard copy that she would like to be distant from everyone else for the present and she was impeccably calm under her current condition. He additionally educated that there were courses of action in those prisons for the treatment of female illnesses.

Ashok Gupta says that,

When I stepped out of the home, when I trained my vision on the outside world, I came face-to-face with such a terrifying reality that I was thoroughly shaken.

It was 1943. Babies were dying in the great Famine, along with so many others, in Bankura. I thought, could I remain aloof, uninvolved, do nothing?...Looking back, I think that that was the first time in my life that I had a taste of freedom, of independence, which inspired me to serve my country...But the happiness I derived from saving the child orphaned by the Famine, bringing back smile to her lips such joy I had never experienced while serving, feeding, and looking after my husband's clamorous family. This work, looking after the helpless, serving society, united me with a similar band of workers. This is what gave me tremendous self-satisfaction and joy, and brought peace to my mind. At last, I felt that I had found something meaningful and a sense of direction that continued to inspire me, through the terrible days of Noakhali, Partition and beyond. (Gupta, 2005, p.77)

This is the means by which Ashoka Gupta recollected first experience with social assistance during 1940s. She unmistakably expresses how the part of the lady was stretched out to the public-how the housewife and mother carried these characteristics to serve the enduring poor.
